### Show Contract

Witnesseth: that for and in consideration of the sum of \$\_\_\_\_\_ for  
full rental, Lessor and Dealer agree to occupy a space that will grant Dealer  
the right to display and sell merchandise at the Central Florida Mineral, Gem  
& Fossil Show to be held at the FLORIDA NATIONAL GUARD ARMORY,  
2809 S. Fern Creek Ave., Orlando, FL 32806 on Apr. 12th, 13th, & 14th, 2019.

The Dealer will be assigned a space according to membership, vendor  
seniority and availability. Space rental will include all tables (8'), chairs and  
electricity. A 50% deposit is to be returned with the signed contract, the  
balance being due and payable 30 days prior to the set-up date of Apr. 12,  
2019. Cancellations will be accepted only when received in writing,  
postmarked no later than 30 days prior to the set-up date of Apr. 12, 2019.  
Cancellations received after Mar. 12th will be considered accrued damages  
and shall accrue to LESSOR. There is a 6 table limit per vendor.

Dealer agrees to limit display and sales to the area assigned and will not  
sublet any portion thereof without authorization of the LESSOR. Dealer also  
agrees not to knowingly mislabel or misrepresent items for sale. Dealer further  
agrees that items for sale will be related to the Mineral, Fossil, Lapidary, Gem  
and Jewelry fields. LESSOR reserves the right to eliminate any exhibit,  
persons, merchandise or advertising which, in the opinion of the LESSOR, is  
not in keeping with the general objectives of the show. Dealer further agrees  
to cover all tables with flame-resistant materials. Nothing will be glued, stapled  
or nailed to the tables, walls or floors of the Florida National Guard Armory  
building.

Dealer will be responsible for the collection and payment of User tax and  
Sales tax to the Florida Department of Revenue of the Florida State and  
County sales taxes. The rate for Orange County is 6.5 percent.

Dealer set-up will be Fri., Apr. 12th, between 7 AM and 1 PM—show opening time. Dealer agrees to be fully set up and ready to operate by 1 PM Friday, Apr. 12th, and should not disassemble/pack-up before 5 PM Apr. 14th. Show hours are 1 PM to 6 PM Fri, 10 AM to 6 PM Sat. and 10 AM to 5 PM Sun. Dealer releases and discharges LESSOR, FLORIDA NATIONAL GUARD ARMORY, and the owner of the facility and assignees of either, from responsibility and/or loss or damage in connection with the Dealers' participation in this show. Dealer and LESSOR agree to comply with all applicable laws and rules that shall be set forth by LESSOR and the Florida National Guard Armory, for the benefit of the general public and/or other participants in the show. Dealer and LESSOR agree to the terms set forth in this contract.
